Rules & Regulations

Responsibilities of members

- Members must follow the rules and by-laws of the Jewel Fest Club.
- Members must uphold the prestige of Thai Gem and Jewelry Busines and take care the interest of the Jewel Fest Club .

- Change of name, surname, nationality, nature of business, place, must notify to the Jewel Fest Club.
- Issue the JFC's certificate to buyers indicating the details of product
- 2. Members are assigned into 4 categories :-
 - 5.1 Founder Member : The First group who found the Club.
 - 5.2 Honorary Member : Honorary Member or Ordinary Member of TGJTA who had paid for the Registration Fee at 50,000 Baht
 - 5.3 Ordinary Member: Honorary Member or Ordinary Member of TGJTA who had joined the Club after the Club had been found.
 - 5.4 Invited Member: Company who is invited by JFC's committees to be a member. Their membership status will last only 2 years counted from the time they pay membership fee.
- 3. Members have voting rights at the general meeting of at special meetings of be elected to be the board of directors.
